Labs and videotapes will be used to problem solve system impairments for infants in general and for the specific infants who will be treated in demonstration sessions. Labs with dolls will augment the therapist’s understanding of infant treatment techniques. **Objectives: At the completion of this course participants will be able to:**

1. Identify and list NDT Infant Treatment Principles.
2. Identify major components of the typical and atypical development.
3. Describe the importance of play as a modality for the infant.
4. Identify system impairments in babies with varied presentations while watching videotapes of assessments and live treatment demonstrations.
5. Reproduce treatment facilitation techniques with dolls.
